
#### **RESPONDENT BY INDUSTRY**




#### Age of Business

- 82 Reduced Hours of Operation. 3 Increased Hours of Operation

- 110 Loss of Revenue. 2 Increase in Revenue
- 78 Reduced Productivity, 2 Increased Productivity

## What percentage of employees in your company have been affected by reduced hours/loss of wages?

52% of respondents say that 100% of their workforce has been affected/impacted

Have you been forced to close your business because of the shelter-in-place order? Nearly 45% of respondents (56) have been forced to close as a result of the shelter in place
