2. Approve Board Term Renewals for Bina Roy Desai & John McKay

Summary: K. Rupp noted that David Dworkin would be retiring his hotel board seat and presented a certificate of appreciation. Summarized efforts made to recruit another hotel representative for the seat were unsuccessful and recommended moving forward with open hotel seat and continual recruitment efforts, as permitted within by-laws. Rupp explained that B. Roy Desai and J. McKay were on one-year terms ending Feb 2024, to balance out the staggered 2-yr terms across board members that was disrupted during covid. Recommended board vote to approve both of them for new 2-yr terms March 2024 – Feb 2026.

Board Comment: Board members expressed gratitude and congratulations to David Dworkin for decades of dedication to the Morgan Hill tourism vision and contribution to bringing forth the TBID establishment. B. Roy Desai commented that new LaQuinta owner would be a good candidate for hotel board seat. Rupp commented that outreach had been made but no response as of yet.

Public Comment: Victoria San Nicolas of LaQuinta commented that she would inquire with owner on next meeting.

3. Brainstorm NBC Universal California Live Film Segment

Summary: K. Rupp presented the paid media opportunity and framed a conversation about potential film locations, messaging, and appearances/talent for a Morgan Hill segment on Bay Area broadcast. Presented two different examples from other destinations (Bear Valley interview style and Walnut Creek voiceover style)

Board comment: Mixed opinion on style of video – many commented to keep the pace of the video interesting by not just having one host the whole-time narrating or incorporating animations/graphics. Many agreed the messaging is our key awareness pillars, key attributes and concentration of assets being enough interest to spend the night. There was discussion around potential pay to play structure and the diplomacy of highlighting individual businesses or owners in the piece. Recommended to keep somewhat evergreen and allow Executive Director to proceed how seeing fit.
